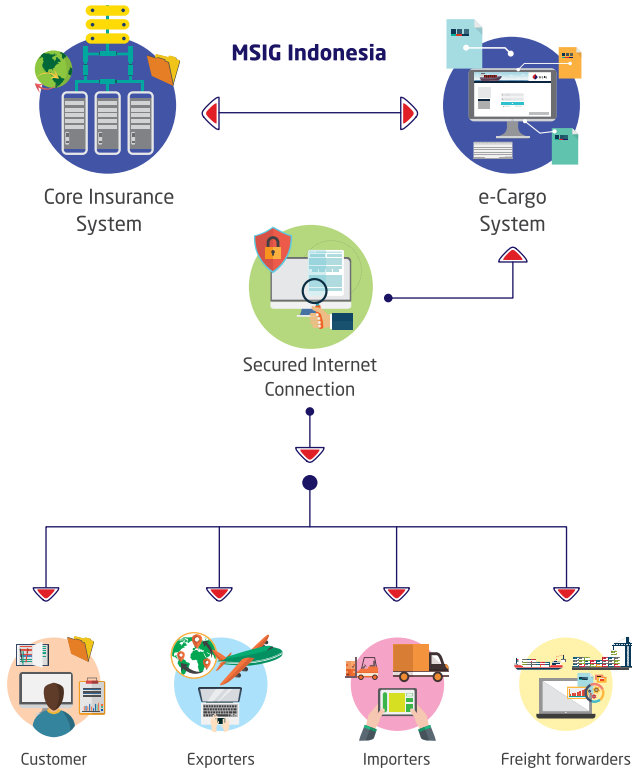

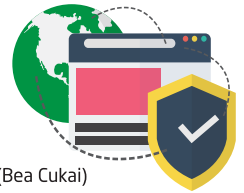


▶ CONVENTIONAL WORKFLOW VS E-CARGO SYSTEM

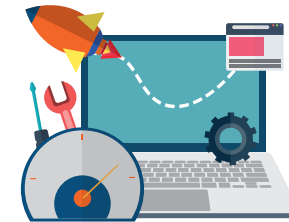

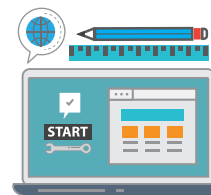


▶ SYSTEM REQUIREMENT
